For Deductions, self-assessment rules apply¹. In the event of a Tax Office Audit, you will need to substantiate the deductions claimed. Please note, our assistance in the audit process would involve additional fees.

If you have sold any assets during the year, please complete our Capital Gain/Loss Form so we can determine whether Capital Gains Tax applies to the transaction(s). A PDF version is available for download from our website at accsysbp.com.au / downloads.
